# **GOVERNANCE FRAMEWORK**

# **Board of Directors ("BOD")**

The Chairman of the BOD is responsible for overseeing proactive measures aimed at identifying and evaluating significant ESG considerations. The Board, in collaboration with the management team, works closely to identify any emerging ESG issues or trends that could substantially impact Awantec's ability to generate long-term sustainable value.

## Sustainability Committee ("SC")

The SC, under the oversight of a member of the board, shall be led by the Chief Executive Officer ("CEO") and comprise the Chief Operating Officer ("COO") along with appointed Heads of Departments ("HODs"). The SC is responsible for implementing and monitoring this policy, with their duties including, among other things, the following.

- Implement the Sustainability Policy approved by the Board.
- Plan and recommend ESG activities/actions for the Board's approval.
- Execute the approved ESG activities/actions approved by the Board.
- Establish measurable objectives for ESG activities/actions.
- Regularly review the adopted Sustainability Policy and approved ESG activities.
- Update and suggest to the Board any required amendments or revisions to the Sustainability Policy should the need arise.
- Ensure that the Board receives sufficient and adequate information for effective decision-making and review.
- Approve the Annual Sustainability Report.

#### Secretariat

Led by the Corporate Governance department, the secretariat is responsible for the following tasks:

- Assist the Sustainability Committee in its administrative activities.
- Coordinate and compile the activity reports submitted by members for deliberation at the Group level.
- To track Board-approved activities and actions to facilitate reporting to the Board and ensure appropriate disclosure.
- Monitoring and reporting on consolidated sustainability activities/actions to the Board.

# POLICY

The policy establishes the overarching principles and foundational framework governing Awantec's sustainability strategy, ensuring that all corporate activities and business operations prioritise sustainable value creation for our shareholders.
